MOMENT OF SILENCE

REPORT FROM COUNTY COUNSEL ON EXECUTIVE SESSION

COMMISSIONER REPORTS

Commissioner Rich began the reports with an update on the Department of Public Works; the resurfacing Route 517 has started, and it will take about 120 days to complete. Route 651 in Kingwood will undergo construction on or about August 4th, weather permitting. Bridge N-1 in Clinton is undergoing repairs and is closed for vehicle traffic but is open for pedestrians use. Mr. Rich reported that Kingwood Township had passed a resolution opposing the proposed Rockfall Mitigation project on State Route 29 just like the Hunterdon County Commissioner Board did. Mr. Rich appreciated Kingwood's position on the matter. The Greater Raritan Workforce Development Board programs are continuing and there are numerous job opportunities available to the public. For more information, Mr. Rich suggested to go to their website.

Commissioner Holt congratulated Megan Muehlbauer for being the recipient of three awards that she received for her hard work and dedication to the Rutgers Extension Program. Mr. Holt reported on the recent milestone that Hunterdon County has reached with Farmland Preservation; over 35,000 acres of land has been preserved since 1985, along with 460 preserved farms in Hunterdon County. Mr. Holt recognized the Planning and Land Use Department and thanked the staff for their help, time, work, and dedication.

Deputy Director Lanza made brief comments about the recent state educational aid cuts to numerous school districts in Hunterdon County. In addition to the school aid cuts, Mr. Lanza noted that once again, the State of New Jersey is not using taxes collected on cell phone bills for their intended purpose of upgrading 9-1-1 systems across the State of NJ. Mr. Lanza thanked the Public Safety Department for their efforts this past Saturday night with heavy rain and flooding.

Director Soloway joined with Commissioner Holt on praising the amount of farmland preservation that has been completed and noted that open space is one of the key reasons to why Hunterdon County is the best county to live in. Ms. Soloway provided an update on the emergency training center. Ms. Soloway thanked U.S. Senator Corey Booker for adding the new emergency services training center to his list of recommended Congressional earmarks. Ms. Soloway also thanked Hunterdon County's Chief of Staff Brad Myhre, for his work as well as other staff on putting the application to the Senator's office together.
